



# SnowCats

Welcome to the sixteenth annual **SnowCat Program!** The program is designed for **ANYONE – 7 and older** who would like to have the opportunity to ski or snowboard at Monarch Ski and Snowboard Area for reduced prices. Participants must read this packet carefully, register online and then turn in proper forms and payment by each due date! The price list is as follows:

## PACKAGE PRICING (all ages 7 and up):

<b>Ski or Snowboard Package: Lift Ticket, Rental, and 2.5-hour *Lesson</b>	\$99 (7-12 yrs.)
<b>Ski or Snowboard Package: Lift Ticket, Rental, and 2.5-hour *Lesson</b>	\$109 (13+ yrs.)
<b>Ski or Snowboard Package: Lift Ticket, Rental, and 4-hour *Lesson</b>	\$139

\*Lesson: First time skiers or snowboarders will be required to attend a 2.5-hour group lesson with the 4-hour group lesson preferable. All other students, ability levels 2/3, will be required to attend lessons until they are a level 4/5. Helmet included. Lunch is included for those students 7-12 years who purchased the 4-hr. lesson package.

## Transportation:

Students, ages 7-18, and SnowCat sponsors will be riding a school bus to the mountain. Students not taking the bus must ride with their parents or guardians. If a student is not returning home on the bus, a consent form must be signed by the parent and the driver must be 21 years of age. Only parents of participating students may utilize school transportation. Community members will provide their own transportation and meet us in the sack lunch area at Monarch by 9:30 or get lift tickets from Group Sales after 9:30.

## Cancellations and Refunds:

If you sign up and pay for a specific SnowCat trip and are unable to attend for whatever reason, the money will be applied to the next SnowCat trip; however **all rentals and lessons are non-refundable within 48 hrs. of the trip.** Please be courteous and notify Carrie Smith as soon as possible if you cannot go, especially if you are unable to attend on the morning of the trip, please call (719) 371-8567.

### **Dress Requirements:**

Skiing and snowboarding takes place in outdoor environments at high mountain elevations. Adapting for ever changing conditions can be a challenge. Here are some things to consider in your preparation process: Dress in **wool or synthetic layers** so you have the option to shed or add clothing as conditions change. Avoid cotton as it gets wet and stays wet. Wear one pair of comfortable **wool or wool blend socks**. Choose **gloves** that are made for winter sports. They should have a water resistant outer shell and light insulating layers inside. Mittens are usually warmer than gloves. **Eye protection** is necessary. Wear sunglasses for clear sunny days or ski goggles for stormy or low light conditions. Having a **stocking cap** available for head and ear protection is recommended. Apply **sunscreen** initially and regularly throughout the day. High altitude rays can find you even on cloudy days. Don't forget the ears and lips, as they are especially vulnerable. **Because SnowCats is a school program, all participants must abide by the school dress code.**

### **Helmets:**

Most participants in the SnowCat program are quickly advancing their skills by experiencing new terrain, jumps, and rails. To help insure the safety of participants, **helmets are mandatory** for SnowCat participants 7-18 years old! Helmets are highly recommended for adults as well. Helmets can be rented through Monarch for \$7.

### **Lunch:**

Monarch has two eateries for lunch, the Gunbarrel Cafeteria and Starbucks. A sack lunch is recommended as the Monarch eateries are expensive. Sack lunches should include a well-balanced meal with a lot of water or liquids and snacks.

### **Bags/Backpacks:**

Make sure you bring a bag or backpack to carry lunches, sunscreen, hats, gloves, goggles, water bottles, and any other appropriate items you feel you might need. To prevent theft, money and valuables need to be kept on you or the bus at all times – do not leave these items in your bag in the lodge.

### **Extracurricular Code of Conduct / Eligibility:**

All middle school and high school students attending SnowCat trips will be expected to follow the guidelines as stated in the Extracurricular Code of Conduct as well as eligibility requirements for each SnowCat trip.

### **Registering for SnowCats:**

Go to the SnowCat website at <http://ccsnowcats.wordpress.com> and follow directions. To participate in the program, every participant needs to register ONLINE for tickets, rentals and/or lessons and sign an ONLINE waiver 8 days prior to each trip. Then, submit payment (checks must be made out to SnowCats) and permission/agreement forms to Carrie Smith at the Custer County School office. Each trip will have a specific Username/Password that will be available on the SnowCat website. If you only need to ride the bus, you still must fill out the permission form and agreement. Please bring extra money for any last minute "emergencies".

# Agreement for Assumption of Risk, Indemnification, Release, and Consent for Emergency Treatment

IN CONSIDERATION OF MY VOLUNTARY PARTICIPATION IN Custer County SnowCats during the 2016/2017 season, I UNDERSTAND THAT I AM BEING ASKED TO CAREFULLY READ EACH OF THE FOLLOWING PARAGRAPHS.

## **Assumption of Risks:**

I understand that skiing or snowboarding, by its very nature, includes certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. Some of these involve broken wrists, torn ligaments, and/or muscle soreness. The specific risks vary, but range from: 1) minor injuries such as bumps, bruises, cuts, to 2) major injuries such as head injuries, broken bones, to 3) catastrophic injuries including death. **I understand and appreciate the risks that are inherent in the above-listed programs and activities. I hereby assert that my participation is voluntary and that I knowingly assume all such risks. I further understand that I am ultimately responsible for my own safety.**

## **Hold Harmless, Indemnity and Release:**

In consideration of permission to participate in the Custer County SnowCats, I agree, for myself, my heirs, personal representatives or assigns, to defend, hold harmless, indemnify and release Custer County Schools and sponsors, from and against any and all claims, demands, actions, or causes of action of any sort on account of damage to personal property, or personal injury, or death which may result from my participation in the above-listed activity. This release includes claims based on the negligence of Carrie Smith and sponsors, employees, agents, and volunteers, but expressly does not include claims based on their intentional misconduct or gross negligence. **I understand that by agreeing to this clause I am releasing claims and giving up substantial rights, including my right to sue.**

## **Consent for Emergency Treatment:**

I authorize Carrie Smith or sponsor, the designated representative to consent, on my behalf, to any emergency medical/hospital care or treatment to be rendered upon the advice of any licensed physician. I agree to be responsible for all necessary charges incurred by any hospitalization or treatment rendered pursuant to this authorization.
